Why ESG Now?

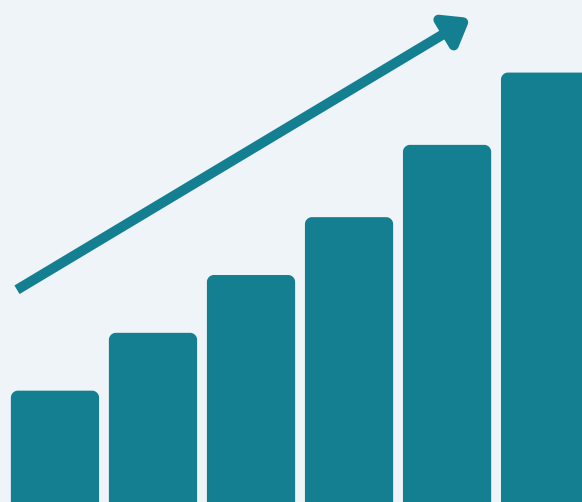

4IP/IPA Impact Measurement & Management (IMM) Services

Many companies and asset managers find ESG principles unclear at the outset of their transition. 4IP/IPA offers a structured approach to help organizations establish strong SDG-aligned impact measurement and management systems. This is achieved through practical training and support on the 4 universal steps of the SDG Impact Standards.

Step 1: Setting an SDG Strategy.

For All Clients:

- Identify material ESG/SDG issues relevant to stakeholders
- Define SDG outcomes aligned with business or investment goals
- Develop an impact thesis for each SDG priority

For Asset Managers:

- Propose a revised Investment Policy Statement (IPS) with integrated SDG goals
- Apply ABC classification levels to SDG-aligned goals

Step 2: Integration

For Enterprises:

- Set clear performance targets
- Choose indicators from the 5 dimensions of impact:
 - (Who, What, How Much, Contribution, Risk)
- Define tracking mechanisms for those indicators

For Asset Managers:

- Integrate IMM processes into every stage of the investment cycle

Step 3: Optimization

For All Clients:

- Determine how impact data will be used to improve performance
- Analyze variance between actual vs. planned impact
- Apply insights to refine strategies and enhance outcomes

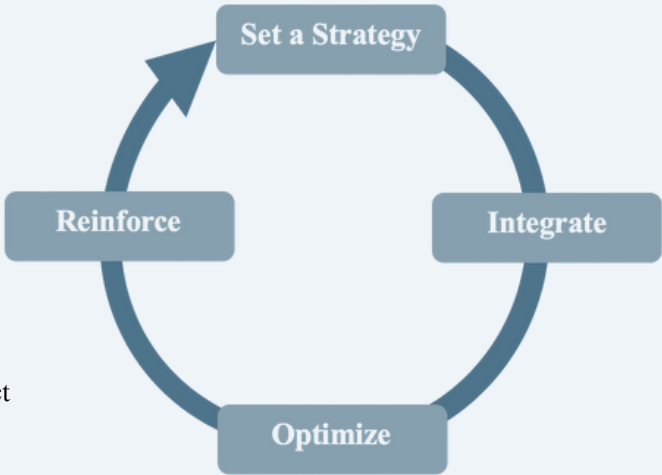
For Asset Managers:

- Review data reported by investees
- Decide on continued engagement or exit strategies based on impact

Step 4: Reinforcement

For All Clients:

- Strengthen governance and accountability frameworks for impact
- Disclose IMM performance to internal and external stakeholders
- Prepare for and leverage 3rd-party verification to enhance transparency and credibility



Each step includes actionable practices tailored for enterprises and investors.

Successful IMM requires alignment between strategy and implementation across all parties.

The IMM journey is cyclical—continuously improving through active management and feedback loops, resulting in stronger systems and measurable SDG impact.
