

Key Details regarding the Coppet Freedom of Speech Debate Series:


- **Context and Location:** The debates are held in Coppet, Canton de Vaud, Switzerland, at the Salle Communale.
- **Historical Significance:** The venue draws on the legacy of the salon hosted by Madame de Staël between 1803 and 1812, which was a historical hub for the exchange of ideas across different cultures and movements.
- **Format:** The events generally involve 8 guest speakers who each argue for or against a specific motion for a maximum of 5 minutes.
- **Example Topics:** A debate held on March 11, 2024, focused on the topic: "ESG and Impact Investing: What's the Difference? Does ESG have a Trust Deficit?".




DRC Investment Inflows by Sector (Indicative Split)

Use for strategy and narrative framing rather than statistical reporting.


Illustrative overview of investment inflows into the Democratic Republic of Congo.


